Sl. No.	The school is directed to ensure that :
1	The number of sections of Bal-Vatika shall be restricted to 3 (one section each in Bal Vatika I, II & III respectively) and total number of sections of the school shall be restricted to 24 from class I to X. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension.
2	The Basketball court is elevated approx. 4 inches and the safety concern raised by the Committee the elevation of the court and ground be even. The DG Set installed in the open area in adjacent to the basket ball ground school shall shift it to some other place or covered. School shall remove the above objection and submit its compliance within 03 months.
3	As admitted by the school in video @25:40, the school is using its basement also for the co-circular activities, the basement area should not be used in any type of academic or co-circular activities school shall undertake that in future the use of basement for students will be restricted and submit its compliance within three months.
4	The ramp made on the entrance of the school building block-I & II is very steep and not safe for access. Since the school has provided the alternate ramp with the lift for access of students. School shall dismantle the ramp and construct the ramp on entrance with proper incline as per guidelines of the Board and norms of RPwD Act 2016 within 03 months and submit the compliance.
5	Plastic chairs have been provided in place of computer chairs for students. No LMS, Webcam, projector or speaker is available in the lab. School shall improve and upgrade the lab in the light of SoP issued by the Board and submit compliance within 03 months.
6	Separate reading area is not developed for staff in the Library. School shall develop separate reading area for staff also and submit the compliance within 03 months.
7	Math lab is understocked, required Models and apparatus are not available as per SoP. Few models are placed on the small tables as makeshift arrangement. There is no space to conduct the activity in the lab. School shall improve and upgrade the lab in the light of SoP issued by the Board and submit compliance within 03 months.
8	The school shall ensure the mandatory training of its teachers with CoE, Vijayawada within 03 months and submit the compliance.


Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned
3. The School shall apply online for extension of affiliation.along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
